STUDIO POLICIES

Absences: Attendance is very important and instrumental to the development of your child's skills. If a student is not able to attend, we ask that you please email the office or text Lisa, Kathi, or Chris to report his/her absence. There are no refunds for missed classes.

Forms: Please remember to turn in your student information/waiver form, Lindsay Law form, and credit card authorization form.

Tuition Due Date: Tuition is always due the first week of the month. A 10% late fee will be applied to all tuition on the 16th. **If you would like to set up credit card automatic payment, please email the office and Lisa will email you the form.** <u>We need a new authorization form each year.</u> There are no deductions or credits for missed classes. Withdrawals must be made before the first class of the each month or you will be billed for the entire **month.**

Parent Observation: We will be staggering the parent observation weeks between dance and gymnastics this year. When it is your child's observation week, you may sit in the classroom/gym and watch your child's classes. **Parent observation for all kinderdance, ballet, tap, jazz, hip hop and pointe classes will be held October 1-7, December 2-7, February 1-7, & April 1-7. Observation for all kindercise, open gymnastics, cheernastics, tumbling and competitive team classes will be October 8-14, December 9-14, February 8-14, & April 8-14.**

Vending: The vending machine will be moved out of the lobby very soon, but we are now selling snacks and drinks at the counter. We have water, Gatorade and an assortment of snacks at the counter ranging from \$1.00 - \$1.50.

OHIO DANCE MASTERS AND CECCHETTI COUNCIL

Ohio Dance Masters and the Cecchetti Council Tuition Scholarships: The deadline for the Ohio Dance Masters College Tuition Scholarship is November 1st. In order to be eligible, you must be a current high school senior, or current college student. First place is awarded \$1,000, second place is \$500 and three remaining finalists will receive \$100. If you are interested in applying for the scholarship, please go to dma-chap16.com/ college-scholarship for the application and requirements. Participation in ODM workshops is advisable. Previous recipients from KDGC include Kaila Frisone, Lauren Owens, Morgan Wardle and Alyssa Swank. This scholarship is heavily

awarded on academics and community service. Dance is a very small percentage of the score. Don't miss an opportunity for scholarship monies.

The CCA of Ohio also offers a College tuition scholarship for high school seniors and college students. The deadline for this scholarship is also January 10th. Students must submit an essay, two letters of recommendation, and a video of a self choreographed piece. Finalists will go through an interview at the Ballet Day held here in February. \$2,250 in scholarship money will be given.


